# Terms and Conditions of Enrolment

## 1. CAMPER DROP OFF AND PICK UP

- 1.1. Parents/guardians must communicate with Malagash Bible Camp office if anyone other than a parent or guardian will be dropping off or picking up their child from camp.
- 1.2. Any applicable conditions of custody or visitation must be fully communicated in writing to the camp, including, if applicable, a photocopy section of any court order referring to visitation rights.
- 1.3. The signature or digital signature on the registration form signifies that both parents/guardians are in agreement with the conditions of enrolment.

## 2. HEALTH AND SAFETY

- 2.1. Care is taken for the safety and good health of campers, but in the event of accident or sickness, Malagash Christian Fellowship/Malagash Bible Camp, including its board of directors, members, staff and agents are hereby released from any liability, including loss, personal injury, accident, misfortune or damage to the registered camper or his/her property, with the understanding that reasonable precautions shall be taken to ensure the health and safety of the registered camper.
- 2.2. Each camper must be covered by Nova Scotia provincial health insurance, or equivalent medical insurance.
- 2.3. All medication will be turned over to the first aid staff upon registration the day of camp for dispensing at prescribed times or as needed. Over the counter medications will be used at the discretion of the medical staff for the following symptoms: colds, coughs, congestion; pain, headaches, fever; stomach upsets, nausea, vomiting; diarrhea; rashes, allergies; cuts, scrapes, burns, unless otherwise indicated by parent/guardian. The dosage of medications given to campers will be as directed by the package unless otherwise indicated by parent/guardian. If you have any preferences or objections to particular medications please indicate on the Medical Release Form.
- 2.4. To ensure the health and safety of your child we have qualified first aid staff and lifeguards for every camp.
- 2.5. In case of medical emergency, I hereby give permission for a member of Malagash Bible Camp staff or directors to transport my child to local hospital for treatment. Furthermore, I hereby give permission to a physician selected by the camp director to hospitalize, secure proper treatment, and to order injection, anesthesia or medical treatment for my child named above.
- 2.6. In the event that a camper requires special medication, x-ray or treatment beyond that which is available at camp, an immediate attempt will be made to notify the parents/guardians. The parents/guardians are responsible for any additional expense that may result from such services.
- 2.7. Malagash Bible Camp does not accept campers who have potentially life-threatening conditions.
- 2.8. According to the Nova Scotia Child and Family Services Act, sections 23(1) and 25(2), it is the duty of Malagash Bible Camp, including all directors, staff, and volunteers to report any and all suspected cases of child abuse or neglect to the appropriate authorities.

## 3. PRIVACY

- 3.1. Malagash Bible Camp respects the privacy of personal information that is submitted to us, and we voluntarily adhere to the CSA Model Code for the Protection of Personal Information. This means that we collect the information only for the purposes of this ministry, we disclose it to others only as required, and we are committed to protecting the information to the best of our ability. We assume that your submission of a camper registration form represents your consent to collect, use and disclose your personal information with the appropriate personnel. We respect your right to withdraw consent at any time.
- 3.2. All information collected in the registration process will only be used by Malagash Bible Camp for the specific purpose of providing your child with a memorable camp experience. In order to do so, Malagash Bible Camp may need to share sensitive information with its staff and all appropriate medical personnel.
- 3.3. Malagash Bible Camp may reasonably use the personal information of a camper, including name, physical address, and email address, to communicate and promote upcoming camps, activities and/or programs. This information will not be shared with any third parties. We respect your right to withdraw consent at any time.

## 4. DISCIPLINARY

- 4.1. The Camp Director reserves the right to dismiss a camper who in his/her opinion is a hazard to the safety and rights of others, or who appears to have rejected the reasonable controls of camp.
- 4.2. Transportation off camp property is the responsibility of the parents/guardian. In the event that the parents/guardian is unavailable or unwilling to pick up a camper on the basis of disciplinary action, the appropriate authorities may be contacted to remove the camper from the camp property.

## 5. REFUND OF FEES

- 5.1. In case of withdrawal greater than fourteen days prior to the opening date of camp, a full refund of fees will be awarded.
- 5.2. In case of withdrawal less than fourteen days prior to the opening date of camp, all but the deposit of \$100 will be refundable.
- 5.3. In case of withdrawal for medical emergencies prior to opening day of camp and with a physician's order, a full refund of fees will be awarded, except a \$25 administration fee.
- 5.4. Registration fees are non-transferrable and substitutes are not permitted.
- 5.5. In case of withdrawal during camp on physician's order, two thirds of the fee for the unexpired term will be refunded.
- 5.6. No refund will be given for dismissals due to disciplinary action.
- 5.7. No fees adjustment for late arrivals or early departures.
- 5.8. Tuck shop funds are considered an optional part of the camp registration fees and unused monies are not refundable or transferrable at the end of the camp week.
- 5.9. All programs require a minimum number of participants before they will run. In case of cancellation of a session, campers will be notified and all fees paid will be refunded.

## 6. PHOTOS AND VIDEO

- 6.1. Malagash Bible Camp may use any still or video image or likeness of the camper for promotional material unless otherwise stated by parents/guardians.
